# KLIMT LANDSCAPES: CREATE YOUR OWN

## SHARE A DRAWING OF YOUR FAVORITE LANDSCAPE FOR A CHANCE TO SEE YOUR WORK DISPLAYED AT THE NEUE GALERIE

Neue Galerie New York is renowned for its resplendent Klimt Gallery, which permanently features works from all periods of the Austrian artist's career. This season, the museum is delighted to present the special exhibition "Klimt Landscapes," on view from February 15 through May 6, 2024, which explores his idyllic depictions of the landscape genre. Surrounded by gardens, forests and lakes, Klimt created beautiful landscape paintings during his annual Sommerfrische (summer holiday) to the Austrian countryside. To celebrate the special exhibition and brighten up the winter season, we invite you to share your interpretation of a favorite landscape. Get some paper and crayons, start drawing, and submit your ideas! Selected drawings will be displayed at the Neue Galerie during the "Klimt Landscapes" exhibition.

### GUIDELINES

Create a drawing, interpreting your favorite landscape. While your submission must be an original work, you are encouraged to study Klimt's different styles and apply them to your drawing. Your artwork must be on letter size paper (8.5 x 11"). You may use pencils (color or black and white), crayons, water color, or collage. Please include a brief (200 words maximum) artist statement, explaining your art. What is special to you about this place? How does it make you feel? All submissions will be reviewed by a jury of Neue Galerie staff, and selected based on creativity and artistic execution.

### HOW TO ENTER

For the chance to have your work displayed on-site at Neue Galerie New York, your submission must be received by Monday, February 12, 2024 at 6 P.M. ET. Submit your drawing by mail (c/o Visitor Services, Neue Galerie New York, 1048 Fifth Avenue, 10028) or drop it off at the Membership Desk during regular museum hours. Submissions received after February 12 are eligible for presentation on the Neue Galerie's digital platforms. We welcome digital submissions by email ([visitorservices@neue-galerie.org](mailto:visitorservices@neue-galerie.org)). Submissions must include the artist's name, age, and for those age 17 and under, a consent form completed by a parent or legal guardian (see next page). There is no submission fee.
