# PAULA MODERSOHN-BECKER DRAWING CONTEST

## SHARE A PORTRAIT OF YOURSELF

This season, the Neue Galerie is delighted to present the special exhibition "Paula Modersohn-Becker: Ich bin Ich / I Am Me," on view from June 6 through September 9, 2024. Paula Modersohn-Becker (1876-1907) is a major figure in the history of German Expressionism. In her brief career, she produced more than 700 paintings and around 1,400 drawings, and many of her works were self-portraits. To celebrate this special exhibition, we invite artists ages 6 and up to share their self-portraits. Get some paper, start drawing, and submit your ideas! All are welcome to participate in the contest, and entry is free.

### **GUIDELINES**

In the spirit of "Ich bin Ich/ I Am Me," we invite you to create a self-portrait, interpreting what it means for you to be you. While your submission must be an original work, you are encouraged to study Paula Modersohn-Becker's style and apply it to your drawing. Your artwork must be on letter size paper ( $8.5 \times 11$ "). You may use pencils (color or black and white), crayons, watercolor, or collage. Please include a brief (200 words maximum) artist statement explaining your art. All submissions will be reviewed by a jury of Neue Galerie staff, and selected based on creativity and artistic execution.

#### HOW TO ENTER

For the chance to have your work displayed on-site at Neue Galerie New York, your submission must be received by **Monday, June 24, 2024 at 6 P.M. ET**. Submit your drawing by mail (Attn: Visitor Services, Neue Galerie New York, 1048 Fifth Avenue, 10028) or drop it off at the Membership Desk during regular museum hours. Submissions must include the artist's name, age (children), and contact information (see form attached). For those age 17 and under, a consent form (see form attached) completed by a parent or legal guardian is required. There is no submission fee. Please note that only those whose works are chosen for display will be notified and that art work will not be returned.
